If you cannot come to the synagogue in person to arrange the sale of *Hametz*, kindly fill out the enclosed form completely, sign it, and return it or mail it to our office to my attention or scan it and email it **as soon as possible**. Remember, it must reach my desk by **Tuesday, March 31st, 2026**, to be included in the sale of *Hametz*, which I will conduct with a gentile before Passover.

Our Sages tell us that when we carefully observe the holiday of Pesach and its intricate laws, we bring the blessing of Hashem upon us in all its fullness and richness.

DELEGATION OF POWER OF ATTORNEY FOR SALE OF HAMETZ (USA ONLY)



 , the undersigned, fully empower and permit **Rabbi Avraham A. Nissanian** to act in my place and stead, and in my benefit to selling all Hametz (as defined by The Torah and Rabbinic Law, e.g., Hametz, doubt of Hametz and all kinds of Hametz mixtures); possessed by me (knowingly and unknowingly); also Hametz that tends to harden and to adhere to a surface on the inside of pans, pots or cooking and usable utensils; also all kind of live animals that have been eating Hametz or mixtures thereof. (*Utensils are not included in the sale*). And to lease all places wherein the Hametz owned by me may be found, especially in my premises at:

Nissanian** full power and authority to appoint a substitute in his stead with full power to sell and to lease as provided herein. The above-given power conforms with all Torah and Rabbinical regulations and laws and follows the laws of the State of New York and the United States.
